


About the Survey Data






Work Patterns – Pre-Pandemic


What was your pre-pandemic pattern for a typical work week?





Desired Work Patterns


During an ideal week what percentage of your time would you want to work in the following locations?

Biggest Gap in Satisfaction Between Working in the Office and Working from Home


Access work files and materials when I need them 20%






